


AI Readiness Checklist

People & Capabilities



Each pillar represents a critical foundation for successful AI implementation. Organisations that excel across all seven areas are positioned for sustainable AI success.





Pillar I: Strategic Alignment

- Clear Business Case
 - ☐ Do you have a clear business case (not "just AI for AI's sake")?
- ৰূত Measurable Outcomes
 - Are AI goals tied to measurable business outcomes (revenue, efficiency, risk)?
- Leadership Support
 - ☐ Is there leadership buy-in and a designated project owner?
 - Pro Insight: 70% of failed AI projects lacked executive sponsorship. Without C-suite backing, AI initiatives often lose momentum and resources before reaching maturity.



Pillar 2: Data Foundations

Data Accessibility

Is your data accessible and unified, not siloed across departments or legacy systems?

Data Quality

☐ Is data quality clean, consistent, and trustworthy enough to train reliable AI models?

Data Governance

Do you have governance frameworks for compliance, privacy, and security of sensitive information?

Pro Insight: Clean data reduces AI project costs by up to 30%. Poor data quality compounds problems downstream and creates expensive rework.

Pillar 3: Tech Stack Audit



Stack Mapping

Have you mapped your current tech stack to understand integration points and capabilities?



Tool Integration

Do your tools integrate seamlessly (APIs, workflows, automation-ready systems)?




Infrastructure Scalability


Can your infrastructure scale with the computational demands of AI workloads?

Pro Insight: Around 40% of AI spend is wasted due to redundant or unused tools. A thorough tech audit before implementation prevents costly overlaps and identifies critical gaps in your architecture.



Pillar 4: People & Capabilities





"Human adoption is the biggest barrier to AI success, not technology."

Organizations that neglect the people dimension of AI transformation face significantly higher failure rates, regardless of technical sophistication.





Pillar 5: Risk & Compliance



Pro Insight: Early compliance reduces long-term legal risk by 50%. Building ethical considerations and compliance into AI from the start prevents costly remediation and reputational damage.


Iteration Framework

Pillar 7: Scaling & Governance

Documentation & Repeatability

Is your pilot documented and repeatable, with clear processes that can be standardised?

Centralised Metrics

Do you track performance metrics in a central dashboard visible to key stakeholders?

Governance Framework

Do you have a governance framework for ongoing monitoring, maintenance, and improvement?

Pro Insight: Scaling without governance creates hidden risks that surface later. A robust governance framework ensures sustainability and prevents "AI debt" as your implementation grows.




